I grant permission to Randy Brown and his production company (hereafter referred to as "Producer") to photograph and record video of my child named above (hereafter referred to as "Bowler") for the purpose of producing a video program called Prodigy Bowlers Tour which may be made available for public viewing on YouTube and other social media websites, the Producer's own website(s), as well as broadcast or cable television. This consent to photograph and video my child for the purposes expressed in this agreement extends for as long as Bowler is competing in youth bowling. I understand and consent to the fact that the show may remain online and available for viewing indefinitely.

I hereby grant the absolute right and permission to the Producer to take, use, reuse, publish and republish any photographs and/or video footage shot for use in the program Prodigy Bowlers Tour for subsequent use in the promotion of said program and/or any highlights packages or promotional reels that might be subsequently produced and packaged.

I consent to the use of these photographic images and video footage shot of Bowler, and further acknowledge and consent to the fact that the Producer will add commentary in the post-production of the Prodigy Bowlers Tour program which will include Bowler's name.

I agree to allow my child to appear on Prodigy Bowlers Tour without compensation. I waive any right to inspect or approve of the final version of the program(s) on which my child appears prior to the show's public release.

I understand that comments posted online by viewers who watch the show on YouTube or other social media websites where the show might be made available for viewing are out of the control of the Producer, and as such, I agree to hold the Producer harmless for any comments posted that may mention or refer to Bowler.

I release, discharge and agree to hold harmless and defend the Producer, his legal representatives or assigns, the bowling center at which the Prodigy Bowlers Tour episode is recorded, any tournament association involved with staging the event at which these recordings are made, and all persons acting under Producer's permission or authority or those for whom he is acting, from any liability by virtue of any reason in connection with the making and use of said photographs and video material, as well as any publication of them, including without limitation any claims for libel or violation of any right of publicity or privacy.

I grant the same permissions retroactively for any previous episode(s) of Prodigy Bowlers Tour on which Bowler may have appeared for which only verbal permission was given to the producer to include Bowler on the program.

I hereby warrant that I am a legally competent adult and parent or legally appointed guardian of the minor, and that I have every right to contract for the minor in the above regard. I have read the above authorization and release, and I agree prior to its execution that I am familiar with the contents of it. This release shall be binding upon the minor and me, and our respective heirs, legal representatives and assigns.
